**“Happy Family Package” is provided by Cathay Pacific. The package consists of round trip air tickets between Singapore and Hong Kong, and Hong Kong Disneyland Park (“Park”) Tickets, for 2 Adults and 1 Child.

Points to Note for Park Ticket redemption

- Redemption Period:** October 1 – December 16, 2016
(Park Tickets not redeemed within the period specified above will be forfeited, neither can they be refunded nor exchanged for cash.)
- Redemption Content:** Three 2-Day Tickets**, being 2 General Admission Tickets and 1 Child Ticket. Tickets are valid on date of redemption. Tickets are non-transferable, non-refundable, void if altered or not validated by Hong Kong Disneyland, and cannot be exchanged for cash.
**2-Day Ticket is valid for visit on any 2 days within a 7-day period. First visit must be on or before the last day of the validity period printed on the back the ticket. Ticket Tag or photo identification required for Park admission.
- Redemption credentials:** 3 guests must present hard copies of their “Happy Family Package” electronic tickets*** and their valid photo ID for verification at the time of redemption.
***The ticket must be printed with “V9KOR02” in the endorsement box for verification. Duplicate ticket number will not be honoured.
- Redemption Location:** Ticket booths at the Main Entrance Hong Kong Disneyland Park from the park open to one hour before the park close.

Park Tickets Rules & Conditions

Admission to Hong Kong Disneyland Park (“the Park”) is subject to the Park Rules and Regulations, which are set out at www.hongkongdisneyland.com, and printed on the Park Guidemap, as the same may be modified by Hong Kong Disneyland at any time and from time to time. Ticket and handstamp (or proof of identity) required for same day re-entry. All persons, bags, parcels and other items may be subject to security checks at the point of admission to the Park and at such other locations inside the Park as Hong Kong Disneyland considers appropriate. Hong Kong Disneyland may from time to time, without prior notice and without refund or compensation, change the operating hours of the Park or attractions, close the Park or any part of it temporarily, restrict the number of persons having access to the Park, and/or suspend or cancel any attraction or entertainment program, due to capacity, inclement weather or special events, to ensure safety, security or order or if Hong Kong Disneyland considers that the circumstances so require. Hong Kong Disneyland is not responsible and does not assume any liability for any damage to or loss of the property or belongings of any Guest, whether such damage or loss is caused by the negligence of Hong Kong Disneyland or otherwise.
