Steps for Pet Travel from Hong Kong

Booking Enquiry Stage

1. Make sure your pet is **not** on the embargo list
<https://www.cathaypacificcargo.com/Default.aspx?tabID=718&language=en-US>

When moving or travelling with brachycephalic (snub-nosed) animals, you are required to work with a pet travel agent, who will ensure they meet all conditions of travel. Please approach [any of the following pet agents](#) when arranging the transportation of a brachycephalic (snub-nosed) pet.

2. Give the Cathay Pacific Cargo Terminal a call at +852-27679888 to reserve a Master Air Waybill (AWB) Number.
3. Make a booking enquiry via Pet Booking e-form (https://cathaypacific.formstack.com/forms/pet_booking) after obtaining the Master AWB Number. If you are a Hong Kong-based customer, you can contact us via Livechat during office hours for any questions.
4. While the booking is not yet confirmed at this stage, you can start looking for a suitable container in accordance with the IATA Live Animals Regulations. Please refer to *Appendix B1 and B2* of this document. Kindly note that the booking process is NOT YET confirmed at this stage.

Make a Booking

5. When the departure date is approaching, our Hong Kong Cargo Reservation team will contact you to confirm your booking with a preliminary quotation if space is available.
6. Prepare the required documents and fill out the forms required for your pet shipment:-
 - a. Required documents (*Appendix A*);
 - b. Kennel Specification (*Appendix B1 and B2*);
 - c. Shipper's letter of instruction for issuing Air Waybill (*Appendix C1*, sample in *Appendix C2*); and
 - d. Shipper's Declaration Letter for Live Animal (*Appendix D1*, sample in *Appendix D2*)



7. Send the following documents to our Hong Kong Cargo Reservation team at cgo#resa@cathaypacific.com. We'll get back to you within two working days:-
 - a. Shipper's letter of instruction for issuing Air Waybill; and
 - b. Shipper's Declaration Letter for Live Animal;
8. Our team at the destination will contact the consignee to confirm the shipment collection details. Our Cargo Terminal **won't** accept your shipment if the consignee hasn't confirmed the collection upon pet's arrival in the departure Cargo Terminal. To avoid any delays, please contact our Hong Kong Sales team via our live chat service on our website **two days before the departure date** and give us your AWB number. We'll check whether the consignee has acknowledged the shipment details and if your pet is ready for carriage.

9. Please see the final checklist (*Appendix E*)
10. Bring your pet, documents required (e.g. Permit / Health Certificates), **signed Appendixes C1 and D1** to Cathay Pacific Cargo Terminal (CPCT) **within four to six hours BEFORE flight departure**
 - a. Location and working hour details (*Appendix F*)
 - b. Proceed to Customer Services Counter on 4/F, Core SE, CPCT for documentations and pet delivery
 - c. Settle your payment by Cash or EPS

11. Collect your pet at the destination; contact destination port for more information about quarantine requirements (if applicable)

Appendices

Appendix A – Pets Travel Documentation

The following information applies mainly to domestic dogs and cats. To obtain further information and advice about shipping your pet overseas or other animals, please contact your local Cathay Pacific Cargo office (<https://www.cathaypacificcargo.com/en-us/aboutcathaypacificcargo/contactus.aspx>). Our staff will be happy to help you.

Special arrangements apply to brachycephalic (snub-nosed) breeds. Please approach [any of the following pet agents](#) for arrangement.

The majority of countries require the following documentation for pets travelling to or via their territory:

- Valid import/export permits from the relevant authority of the countries.
- Valid health certificate from a registered veterinarian, stating that the pet is free from rabies and any other diseases.
- Valid vaccination record to show that the pet has received all necessary vaccinations.
- Any additional documentation or validations required by the destination country.
- Transit permits and any other documentation required by the relevant authority of all transit countries.

Some countries require your pet to be microchipped and/or quarantined. Please ensure that you are fully aware of the specific requirements of your destination country.

Please note that these requirements vary from country to country and are subject to change.

Please check with local authorities for specific documentary requirements of the destination country and any transit countries, please refer to the publications or websites of local authorities.

Appendix B1 – Kennel Requirements

The construction and design of the containers must comply with the IATA Live Animals Regulations. In general, containers must be appropriately sized, well-ventilated, rigid and fitted with solid and leakproof flooring. In addition, they must comply with the following regulations:

- Containers must be constructed from fibre-glass, metal, rigid plastics or welded metal mesh. No wooden cage is allowed.
- Foldable container fixing by removable pin will not be accepted for carriage as it is not a rigid design.
- Containers made entirely of welded mesh or wire mesh will not be accepted.
- Containers must be clean and leak-proof.
- Any wheels attached to the container must be removed.
- Animals must be able to stand, turn and lie down in a natural manner.
- Containers must be adequately ventilated, ventilation must be provided on all 4 sides of the container. Ventilation openings on the sides and the back must be placed over the upper two thirds of the container. The door must be ventilated from the top to the bottom.
- The maximum size openings in the welded mesh is 25 mm x 25 mm (1 inch x 1 inch) for dog's container, and 19 mm x 19 mm ($\frac{3}{4}$ inch x $\frac{3}{4}$ inch) for cat's container. All openings must be nose and paw-proof.
- Water container must be present within the container with outside access for refilling.
- Water container must be open on the top surface allowing the animal unrestricted access and must be securely affixed to the inside of the shipping container.
- Water bottles or similar dispensers that are attached either inside or outside the shipping containers are not considered to be open containers.
- Separate food and water troughs should be provided and easily accessible for replenishment in case of delay.
- All feeding and watering instructions must be provided in writing and affixed to the outside of the container.



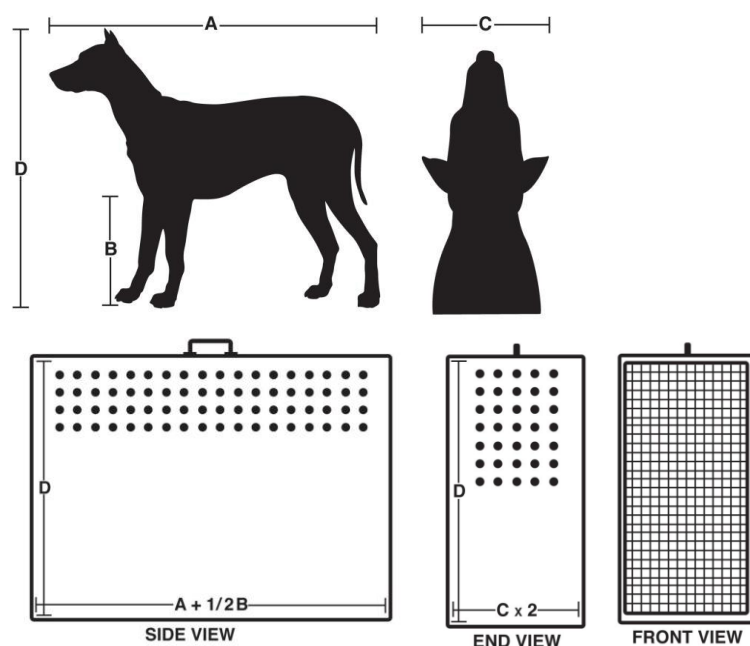
For Cat: Smaller than 19mm x 19mm
For Dog: Smaller than 25mm x 25mm



Appendix B2 – Kennel size – An example

It is important you purchase the right sized container for your dog or cat. The following indications are to ensure pet has enough space to turn about normally while standing, to stand and sit erect, and to lie in a natural position.

Special arrangements apply to brachycephalic (snub-nosed) breeds. Please approach [any of the following pet agents](#) for arrangement.



Index

- A. From the tip of the nose to the root of the tail
- B. From the elbow to the ground
- C. The width of the dog at the widest point
- D. From the floor to the tip of the ears or the top of the head, whichever is higher. Ears must not touch the top of the kennel when animal standing naturally

Calculation of kennel's dimension

$A + \frac{1}{2} B = \text{Length}$

$C \times 2 = \text{Width}$

$D = \text{Height}$

Above dimensions are internal measurements. Kennel not meeting these criteria will be refused uplift. You may use the spreadsheet for calculation purpose from the link below:

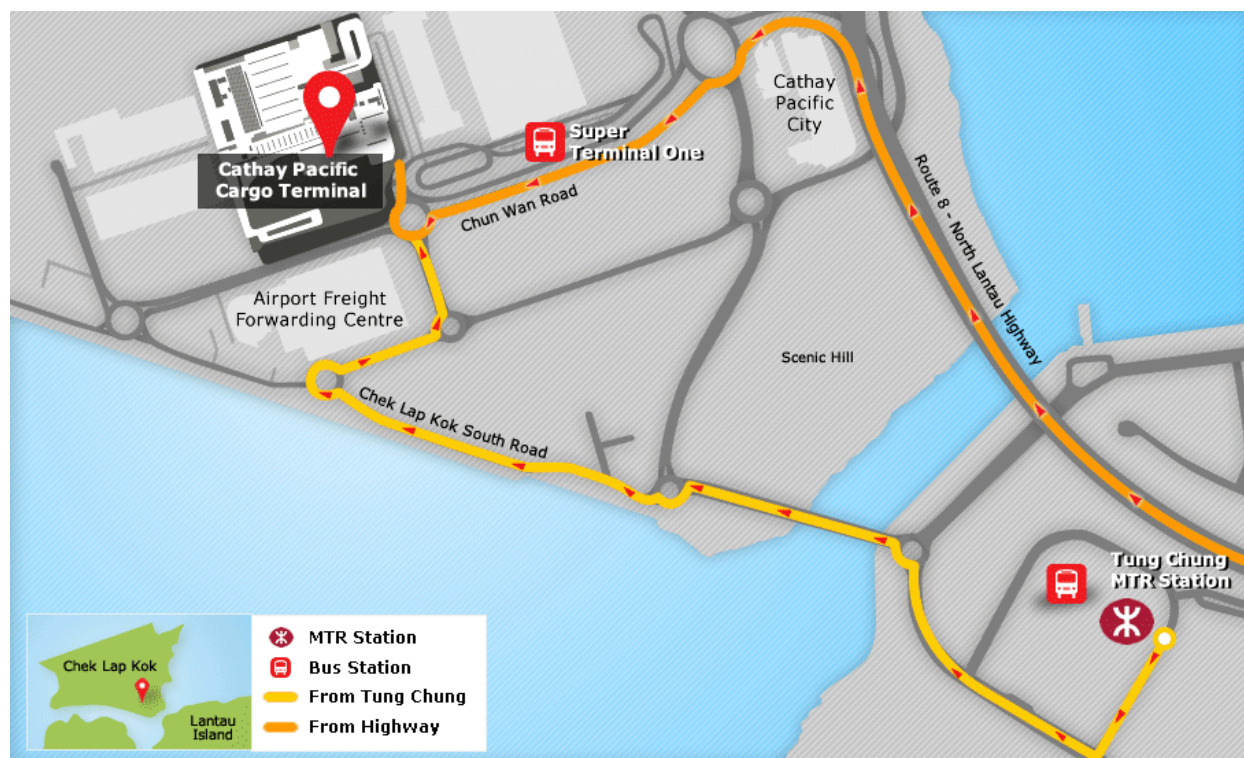
