Terms and conditions

For The Promotion Offer

- The Points Conversion Campaign ("Promotion Offer") provided by Asia Miles Limited ("AML") is valid from 17 June 2024, 00:00 to 16 August 2024, 23:59 (GMT+8), both dates inclusive ("Promotion Period").
- 2. This Promotion Offer is only applicable to selected members who are the intended recipients of designated promotional emails/SMS and whose preferred mailing country is Hong Kong ("Selected Members").
- Under this Promotion Offer, Selected Members who have fulfilled the following requirements ("Eligible Members") can enjoy an extra 10% Asia Miles ("Bonus Miles") and an additional reward of a 3-course set dinner for two at Felix, The Peninsula, Hong Kong ("Dining reward"):
 - i. Register for the Promotion Offer via the designated link on or before 16 August 2024, 23:59 (GMT+8); AND
