

# **Cathay Privileges Terms and Conditions**

Cardholders of Standard Chartered Cathay Mastercard® - Priority Banking, and Standard Chartered Cathay Mastercard® - Priority Private can enjoy a suite of Cathay privileges including complimentary lounge passes, priority check-in, priority boarding, spending and Asia Miles redemption privileges.

### **Cathay Co-branded Card Lounge Passes**

#### **Eligibility**

- Eligible cardholders of Standard Chartered Cathay Mastercard Priority Banking can enjoy four sharable Business class lounge passes per credit card membership year.
- Eligible cardholders of Standard Chartered Cathay Mastercard Priority Private can enjoy two sharable First class and eight sharable Business class lounge passes per credit card membership year.

#### **General Terms and Conditions**

- Sharable lounge passes are valid for use by the eligible cardholders, their travel companion or redemption group nominee (as defined in the Cathay Membership Programme Terms and Conditions) to use before flights that are marketed or operated by Cathay Pacific
- Each sharable lounge pass is valid for one person only for a single entry into any Cathay Pacific operated lounges. The lounge pass is not eligible for admittance to other lounges not operated by Cathay Pacific
- Sharable lounge passes must be claimed via the Cathay apps (applicable to Cathay member)
  or via email (not a Cathay member), and are not available at airport check-in or by calling our
  Customer Care Team (as defined in the Cathay Membership Programme Terms and Conditions)
- Redemption group nominee who has received the sharable lounge pass from the eligible cardholder can enjoy the lounge services even if he/she is not travelling with the eligible cardholder
- Travel companion must be accompanied by the eligible cardholder when entering the lounge
- The lounge pass will be considered used when the QR code has been scanned by the lounge team
- Sharable lounge passes are valid within the credit card membership year. While using the pass, eligible cardholders' credit card and Cathay membership account must be valid and not suspended or terminated
- The shared lounge pass can be cancelled via the Cathay apps by the eligible cardholder anytime if it has not been used. The lounge pass will be added back to eligible cardholder's Cathay membership account once cancelled
- The sharable lounge passes can only be used within the validity period. The validity period of the lounge pass will not be extended under any circumstances



- The sharable lounge passes have no cash value and cannot be redeemed or exchanged for cash or any other items. If lost or damaged, no replacement will be issued
- Access to lounges is subject to the applicable law of the country that the lounge is located in and the lounge operator's rules and policies

#### Standard Chartered Cathay Mastercard - Priority Banking

Eligible cardholders, their travel companion or redemption group nominee must present their
one-time lounge pass QR code alongside their boarding pass with Cathay Pacific flight number
when entering any of the Cathay Pacific Business class lounges. Eligible cardholders, their
travel companion or redemption group nominee will not be admitted if they present their
Standard Chartered Cathay Mastercard – Priority Banking

#### Standard Chartered Cathay Mastercard – Priority Private

- Eligible cardholders, their travel companion or redemption group nominee must present their
  one-time lounge pass QR code alongside their boarding pass with Cathay Pacific flight number
  when entering any of the Cathay Pacific First and Business class lounges. Eligible cardholders,
  their travel companion or redemption group nominee will not be admitted if they present
  their Standard Chartered Cathay Mastercard Priority Private
- Eligible cardholders, their travel companion or redemption group nominee with valid First class lounge passes may access Business class lounges if a First class lounge is not available

### **Priority Check-in**

#### Standard Chartered Cathay Mastercard – Priority Banking

- Eligible cardholders who are travelling on flights operated by Cathay Pacific can enjoy priority check-in
- Eligible cardholders may check in at our Premium Economy counters. Alternatively, they can use our bag-drop counters. This benefit does not extend to the Business or First counters
- Eligible cardholders must present their Cathay mobile membership card via the Cathay apps when they check in
- Only eligible cardholders can use this benefit. This benefit is not extended to travel companions

#### Standard Chartered Cathay Mastercard – Priority Private

 Eligible cardholders who are travelling on flights operated by Cathay Pacific can enjoy priority check-in



- Eligible cardholders may check in at our Business counters. Alternatively, they can use our bag-drop counters. This benefit does not extend to the First counters
- Eligible cardholders must present their Cathay mobile membership card via the Cathay apps when they check in
- Travel companion(s) can also enjoy this benefit when they travel with eligible cardholders

### **Priority Boarding**

#### Standard Chartered Cathay Mastercard – Priority Banking

- Eligible cardholders can enjoy the same boarding line for Premium Economy passengers on flights operated by Cathay Pacific. Alternatively, join the boarding line for Economy passengers if Premium Economy is not available
- Eligible cardholders must present their Cathay mobile membership card via Cathay apps when they board
- Only eligible cardholders can use this benefit. This benefit is not extended to travel companions

#### <u>Standard Chartered Cathay Mastercard – Priority Private</u>

- Eligible cardholders can enjoy the same boarding line for Business passengers on flights operated by Cathay Pacific
- Eligible cardholders must present their Cathay mobile membership card via Cathay apps when they board
- Travel companion(s) can also enjoy this benefit when they travel with eligible cardholders

'Redemption group' refers to a group of up to 5 family members and/or friends nominated by the eligible cardholder, for whom the eligible cardholder can redeem their Asia Miles for awards. More information on redemption groups is available on the Cathay website

### **Cathay Pacific Business Lounge Access Redemption**

- Eligible cardholders of Standard Chartered Cathay Mastercard, Standard Chartered Cathay
   Mastercard Priority Banking and Standard Chartered Cathay Mastercard Priority Private
   may use Asia Miles to redeem Cathay Pacific Business lounge access for themselves, friends
   or family members; this is not limited to the redemption group nominee. Lounge access
   redemption does not extend to Cathay Pacific First class lounges.
- Eligible cardholders are required to redeem the lounge access online at least 3 weeks prior to the flight



- A lounge redemption letter will be sent to the address provided by normal mail after eligible cardholders have completed the redemption. Please present the original redemption letter to Cathay staff when entering any of the Cathay Pacific Business class lounges
- Other terms and conditions apply. Please refer to the lounge access redemption form for details

#### **Status Points**

- Eligible cardholders of Standard Chartered Cathay Mastercard, Standard Chartered Cathay Mastercard Priority Banking and Standard Chartered Cathay Mastercard Priority Private can earn 20 Status Points for every eligible HKD100,000 eligible transactions, and up to 100 Status Points in a calendar year, starting on 1 January and ending on 31 December
- Status Points will be credited to eligible cardholders' Cathay membership account according to the phases below:
  - 1 January 31 March 2025 (Phase 1) the Status Points rewarded will be credited on or before 30 June 2025
  - 1 April 31 June 2025 (Phase 2) the Status Points rewarded will be credited on or before 30 September 2025
  - 1 July 30 September 2025 (Phase 3) the Status Points rewarded will be credited on or before 31 December 2025
  - 1 October 31 December 2025 (Phase 4) the Status Points rewarded will be credited on or before 31 March 2026
- Status Points are not transferable to other airline programmes
- Eligible cardholders' Cathay membership account and Standard Chartered Cathay Mastercard account must remain valid when the Status Points are credited, otherwise Cathay Pacific Airways Limited has the right to forfeit the Status Points earned and accepts no liability and will not be liable for any compensation
- Eligible cardholders can earn Status Points as well as Asia Miles when they spend on eligible transactions. Status Points contribute to Cathay membership, while Asia Miles enable eligible cardholders to redeem a range of travel and lifestyle rewards
