

## Standard Chartered Cathay Mastercard®

### LANDMARK Dining in Central Club Pass Exclusive Privileges

#### Terms and Conditions

1. The Standard Chartered Cathay Mastercard – LANDMARK Dining in Central Club Pass Exclusive Privileges (“**Offer**”) is from 1 July 2026, 00:00 (GMT +8) to 31 March 2027, 23:59 (GMT +8), both dates inclusive (the “**Promotion Period**”).
2. The Offer is only applicable to the principal cardholders (“**Cardholders**”) of Standard Chartered Cathay Mastercard, Standard Chartered Cathay Mastercard – Priority Banking and Standard Chartered Cathay Mastercard – Priority Private (each an “**Eligible Card**”) issued by Standard Chartered Bank (Hong Kong) Limited (the “**Bank**”).
3. The Offer is provided by Cathay Pacific Airways Limited and Asia Miles Limited (collectively “**Cathay/AML**”), in collaboration with Hongkong Land Bespoke Limited (“**LANDMARK**”).
4. To enjoy the Offer, Cardholders should ensure their Eligible Card is successfully linked to their relevant Cathay membership profile through [Card Linked Earn](#) (“**Linked Card**”), before making any Eligible Purchases.
5. For the purposes of this Offer:
  - i. “**Dining Pass**” refers to the LANDMARK Dining in Central Club Pass. For details, please refer to the [LANDMARK Dining in Central Club Pass Page](#).
  - ii. “**Dining Pass Entitlements**” refers to the privileges of the Dining Pass, as stipulated at the [LANDMARK Dining in Central Club Pass Terms and Conditions](#).
6. Cardholders are entitled to enjoy the following exclusive privileges for the Purchases of Dining Pass (whether made online or offline) directly made with their Linked Card during the Promotion Period (“**Eligible Purchases**”)(“**Eligible Dining Pass holders**”):
  - i. Additional Privileges provided by the following restaurants (“**Additional Privileges**”):
    - a) Amber – 15% discount on the Full Amber Experience and Extended Amber Experience for weekday lunch (food only); and
    - b) SOMM – 15% discount on à la carte menus (food only) for lunch and dinner, excluding weekend and public holiday brunch periods

Cardholders may enjoy the above dining privileges once per day until 31 March 2027, subject to availability and the terms and conditions of the above restaurants.
  - ii. Bonus Asia Miles at a rate of 1 Asia Mile for every HKD 6 spent (“**Bonus Miles**”) on the Purchases (rounded down to the nearest whole mile):

7. Eligible Dining Pass holders are required to redeem their Dining Pass and additional Amber and SOMM privileges by 31 March 2027, during the operating hours, at any one of the following LANDMARK concierges: G/F LANDMARK ATRIUM; 2/F LANDMARK ATRIUM (next to York House); 1/F LANDMARK CHATER; or 1/F LANDMARK PRINCE'S.
8. Cardholders must download the latest version of the LANDMARK App and be a BESPOKE member to receive the Dining Pass Entitlements upon redemption.
9. Cardholders are required to present a valid BESPOKE member profile, the redemption QR code included in the purchase confirmation email, as well as their Linked Card used for the Purchases at the Concierge counter. Upon successful verification, Dining Pass, and all associated entitlements, will be redeemed and activated.
10. The Dining Pass, and all associated entitlements, will automatically expire and become invalid by 23:59 on 31 March 2027.
11. For the avoidance of doubt, Purchases shall be directly made in full with a Linked Card and are posted to the Eligible Card account in Hong Kong Dollars. Any partial payment, or transaction through Octopus Wallet, Alipay account, Wechat account, Payme account and other digital payment accounts are not Eligible Purchases.
12. Eligible Purchases shall be made in Hong Kong Dollars. Any Purchase made in a currency other than Hong Kong Dollars will be considered ineligible for the Bonus Miles. Cathay/AML reserves the sole right in determining whether a transaction falls within the meaning of Eligible Purchases.
13. Cathay/AML will automatically credit the Bonus Miles to the Cathay membership account linked with the Cardholder's Eligible Card after such Eligible Purchase is validated. Cardholder shall contact Cathay/AML by submitting a claim within ten (10) weeks of making the Purchase, if he/she does not receive the Bonus Miles; otherwise the Bonus Miles will be forfeited, and Cathay/AML will not be

responsible for any compensation.

14. Cardholder shall hold a valid Cathay membership account and a valid Eligible Card at the time when the Bonus Miles is credited; otherwise, the Bonus Miles will be forfeited without further notice.
15. The Bonus Miles cannot be converted into bonus points, cash rebates or cash or otherwise, and is non-transferable and non-exchangeable.
16. If the Eligible Purchases are otherwise cancelled or refunded, without prior notice to the Cardholders, Cathay/AML has the right to forfeit the Bonus Miles including cancelling or reversing any Miles credited to the Cardholder's Cathay membership account.
17. Cardholders are required to keep the relevant original sales receipts and credit card sales slips (where applicable) for inspection upon request by Cathay/AML. In case of disputes, Cardholders are required to submit the relevant original sales receipt(s) and credit card sales slip(s) for further investigation by Cathay/AML. All relevant documents submitted will not be returned. In case of discrepancy between Cathay/AML's computer record and details recorded on the credit card sales slips, Cathay/AML's computer record(s) shall prevail.
18. Cathay/AML, LANDMARK and the Bank will not and have no obligation to confirm which Purchases are eligible for the Offer before the Purchases are made.
19. Cardholders understand and accept that the Bank is not the supplier of the Cathay membership account, Asia Miles and the products / services purchased / redeemed with Asia Miles. Cathay/AML, LANDMARK and the Bank make no representation, warranty or guarantee, whether express or implied, in respect of the goods or services provided by any participating merchant, including but not limited to their quality, quantity, fitness for purpose or availability, and accepts no liability whatsoever arising from or in connection with such goods or services or Additional Privileges provided by the participating merchant. Each participating merchant shall be solely responsible for all obligations, liabilities, claims and responsibilities relating to the goods and services and Additional Privileges it provides. Cathay/AML, LANDMARK and the Bank shall not be responsible or liable to customers or any other party for any liability, loss, damage, claim, cost, or expense whatsoever and howsoever arising, whether directly or indirectly, in respect of, relating to or in connection with the redemption, use or enjoyment of any of the Dining Pass Entitlements.

### LANDMARK 「Dining in Central 餐饗通行證」專屬禮遇

#### 條款及細則

1. 此渣打國泰 Mastercard® – LANDMARK 「Dining in Central 餐饗通行證」專屬禮遇（「禮遇」）的推廣期為 2026 年 7 月 1 日凌晨 12 時（GMT + 8）至 2027 年 3 月 31 日晚上 11 時 59 分（GMT + 8），包含首尾兩天（「推廣期」）。
