Cigna Cathay Premier Health Plan - Flight Credits Promotion Terms and conditions

- 1. Unless otherwise defined in these terms and conditions ("**Terms**"), capitalised terms in these Terms shall have the following meaning:
 - a) "Asia Miles by Cathay App" refers to the application of AML that allows users to use on mobile or desktop devices.
 - b) "Cathay Membership Programme" means the travel and lifestyle awards and relationship programme owned by Cathay, and operated and managed by AML.
 - c) -"Designated Product" means the Cigna Cathay Premier Health Plan.
 - d) "Eligible Policy" means a policy issued under the Designated Product, with a Policy Inception Date within the Promotion Period.
 - e) "Member" means any person who is a member of the Cathay Membership Programme.

 - j) "Flight Credits" means the discount worth HK\$1,500provided by Cathay that can be used to book travel on flights marketed and operated by Cathay.
- This promotion, as further described in paragraph 5 of these Terms
 ("Promotion") is organised by Cathay Pacific Airways Limited ("Cathay"), Asia
 Miles Limited ("AML") (Cathay and AML collectively are, "Cathay/AML") and
 Cigna Worldwide General Insurance Company Limited ("Cigna Healthcare").
- 3. The Promotion commences on 1 April 2024, 00:00 and ends on 30 June 2024, 23:59 (both days inclusive, Hong Kong Time, GMT+8) (the "**Promotion Period**").
- 4. In addition to the criteria set out in paragraphs 6 and 7, the Promotion is only available to a Policy Holder ("Eligible Participant") who satisfies the following criteria:
 - a) is aged 18 years or older;
 - b) holds a valid Hong Kong Identity Card; and
 - c) resides in Hong Kong.

Each Eligible Participant is required to provide the correct Cathay Membership Programme number and registered email address to Cigna Healthcare when they apply for the Eligible Policy in order to receive the Offer. Cathay/AML reserves the right to refuse sending out the Discount Code of the Offer if any information provided to Cigna Healthcare is incorrect or required information is missing.
- 15. By participating in the Offer, each Eligible Participant agrees and accepts to be bound by these Terms.
- 16. All applications for the Designated Product are subject to underwriting and approval by Cigna Healthcare. Cigna Healthcare reserves the right to accept or decline any application.

- at any time without prior notice. The continued participation in the promotion by an Eligible Participant after any amendments or modifications have been made will indicate his or her acceptance of such amendments or modifications to these Terms.
- 18. All matters and disputes relating to the Offer, and these Terms, will be subject to the final decision of Cathay/AML and Cigna Healthcare.
- 19. The Cathay Membership Programme <u>Terms and Conditions</u> (including the Wellness Journey Terms and Conditions) shall also apply. To the extent there is any inconsistency, these Terms shall prevail.
- 20. Cathay is an authorized insurance agent (FA3522) of Cigna Healthcare, and Cathay/AML are not responsible for any insurance products issued by Cigna Healthcare, or any information provided by Cigna Healthcare in relation to insurance products in connection with the Offer or otherwise.
- 21. These Terms shall be governed by and construed in accordance with the laws of Hong Kong SAR.
- 22. If there is any inconsistency or conflict between the English and Chinese versions of these Terms, the English version shall prevail.
- 23. Personal data collected, used, stored, disclosed or otherwise dealt with in connection with this Promotion shall be processed in accordance with the Cigna Healthcare Personal Information Collection Statement and Cathay/AML privacy policy.
