

**Limited Time Bonus Miles Offer for purchase the Single
Trip Chubb Premier Travel Cover Terms and Conditions**

1. This limited time offer for Chubb Premier Travel Cover, a single trip travel insurance (this **"Offer"**, as described in greater detail below) is organized by Cathay Pacific Airways Limited (**"Cathay"**), Asia Miles Limited (**"AML"**), and herein referred to together with Cathay as **"Cathay/AML"**, **"us"**, **"we"** or **"our"**) and Chubb Insurance Hong Kong Limited (**"Chubb"**).
2. These terms and conditions apply to the awarding of Asia Miles by Cathay/AML to customers who are Members (as defined below) who purchase Chubb Travel Insurance (as defined below) through the Channels (as defined below) (herein referred to as **"you"** or **"your"**).
3. This Offer commences on 3 June 2024, 00:00 and ends on 3 September 2024, 23:59 (both days inclusive, Hong Kong Time, GMT+8) (the **"Promotion Period"**).
4. Chubb and Cathay/AML reserve the right to amend or vary these terms and conditions during the Promotion Period and to cancel, suspend or terminate this Offer at any time, with or without notice to you.
5. You acknowledge and agree that by requesting for the award of Asia Miles in connection with your purchase of the Chubb Travel Insurance through the Channels and participating in this Offer, you are agreeing to these terms and conditions and any amendments or variations to these terms and conditions.
6. The following capitalised terms used in these terms and conditions have the meaning ascribed to it:

"Cathay Membership Programme" means the loyalty and rewards programme operated by AML (as such programme may be renamed, rebranded, amended or replaced from time to time);

"Cathay Website" means https://www.cathaypacific.com/cx/en_HK.html;

"Channels" means the Cathay flight ticket booking [website](#) and the [Chubb dedicated website](#);

"Chubb Travel Insurance" means the Chubb Premier Travel Cover, a single trip travel insurance cover for journey departing from Hong Kong;

"eForm" means the [designated registration eForm](#) to request an award under this Offer; and

"Member" means a current member of the Cathay Membership Programme with a membership account in good standing.

7. You must meet the following requirements to be eligible to receive Asia Miles in connection with your purchase of the Chubb Travel Insurance (“**Eligibility Requirements**”):
 - a. you must be a Member;
 - b. you must be at least 18 years of age;
 - c. you must fill in and submit the eForm on the Cathay Website within 21 days after purchasing the Chubb Travel Insurance; and
 - d. you must have purchased the Chubb Travel Insurance through the Channels during the Promotion Period.
8. To request an award of Asia Miles in connection with your purchase of the Chubb Travel Insurance, you must fill in and submit the eForm on the Cathay Website within 21 days after the Chubb Travel Insurance is purchased during the Promotion Period.
9. When completing the request eForm, you must provide all the information requested on the registration eForm and ensure that all information you have provided are complete and accurate; such information including your Cathay Membership Programme membership number, your Chubb Travel Insurance policy number, and your surname and first name as registered in your Cathay Membership Programme membership account. Cathay/AML will not be liable if you fail to receive Asia Miles because of your failure to provide correct or incomplete information.
10. After fulfilling the Eligibility Requirements, you will be eligible to receive 500 Asia Miles, if the premium of the policy that you have purchased is lower than or equivalent to HKD500; or if the premium is greater than HKD500 then you will receive one (1) Asia Mile for every one (1) Hong Kong Dollar of the premium. If you are eligible to receive such Asia Miles under this clause, the Asia Miles will be credited to your Cathay Membership Programme membership account within 7 days of Cathay/AML receiving your completed eForm and being satisfied that you have fulfilled the Eligibility Requirements under these terms and conditions or from the policy effective date (whichever is the later date).
11. You may only make a request to be awarded Asia Miles once for each Chubb Travel Insurance policy you purchased during the Promotion Period.
12. The Chubb Travel Insurance policies are provided and underwritten by Chubb. Cathay is an authorised insurance agent (FA3522) of Chubb in Hong Kong, and Cathay/AML are not responsible for any insurance products issued by Chubb, or any information provided in relation to insurance products in connection with this Offer or otherwise. Chubb Travel Insurance policies are subject to the terms and conditions of the insurance policies determined by Chubb.
13. If your Chubb Travel Insurance policy is cancelled, terminates or expires before your journey departure, you will not be eligible to receive any Asia Miles in connection with the Chubb Travel Insurance policy.
14. This Offer to award Asia Miles in connection with the purchase of Chubb Travel Insurance is not transferable, exchangeable, returnable or redeemable for cash, and cannot be used in conjunction with other promotional offers.

15. Cathay may at any time cancel or reverse Asia Miles credited or refuse to credit any Asia Miles to your Cathay Membership Programme membership account if without limitation:
 - a. Asia Miles have been awarded to you due to any error;
 - b. Chubb refunds any premiums you paid to Chubb on the Chubb Travel Insurance policy for any reason;
 - c. you fail to comply with these terms and conditions and/or the Cathay Membership Programme terms and conditions;
 - d. Chubb notifies us that you have failed to comply with the terms and conditions applicable to the Chubb Travel Insurance policy you have purchased; and/or
 - e. you commit any misconduct or fraud or otherwise act illegally, dishonestly, misleadingly, deceptively or fraudulently in connection with the Chubb Travel Insurance, the Cathay Membership Programme, or this Offer under these terms and conditions.

16. Your purchase of Chubb Travel Insurance is subject to underwriting and approval by Chubb. Chubb reserves the right to accept or decline any application for Chubb Travel Insurance.

17. All matters and disputes relating to this Offer and these terms and conditions are subject to the final decision of Cathay/AML.

18. The Cathay Membership Programme Terms and Conditions apply. To the extent there is any inconsistency, these terms and conditions shall prevail.

19. These terms and conditions shall be governed by and construed in accordance with the laws of Hong Kong SAR.

20. If there is any inconsistency or conflict between the English and Chinese versions, the English version shall prevail.
