

## 2026 Pre-Summer Campaign – Bonus Miles for Chubb Travel Insurance Terms and Conditions

1. This offer for **Chubb Travel Insurance** (this “**Offer**”, as described in greater detail below) is organized by Cathay Pacific Airways Limited (“**Cathay**”, “**us**”, “**we**” or “**our**”) and Chubb Insurance Hong Kong Limited (“**Chubb**”).
