- Still Camera/Digital Camera
- Oven Rice Cooker/Pressure Cooker/with Gas and Burner)
- Toaster / Sandwich Maker / Blender / Food Processor / Juicer / Coffee Maker
- Household Sewing Machine > Table / Pedestal Fan / Household Ceiling Fan
- Sports Series (for personal use)
- Gold ornaments weighing 100 grams and silver ornaments weighing 200 grams (One type of ornament is no more than 12)

Baggage not brought with passenger to be redeemed

Unaccompanied Baggage (Unaccompanied Baggage) can be exempted without duty (tax) subject to giving proper declaration subject to compliance with the rules. The declaration form (Schedule-1) is given to the passengers in the aircraft before landing, or is available at customs. If it is not possible to make the declaration before leaving the customs hall due to mistake or unavoidable reasons, the declaration must be made at the Customs House, Dhaka, within 07 (seven) days of the passenger's arrival. A copy of the declaration must be submitted to the airport customs officer at the time of baggage release

Necessary instructions for carrying Gold

Guidelines for carrying gold:

A passenger can carry a maximum of 234 grams or 20 tolas of gold by declaring it at the customs hall and paying the following taxes:

- Duty/Tax per 11.664 grams = 2,000 Taka
- Duty/Tax per 234 = 40,000 Taka (Approx.)

Any amount of gold in excess of 234 grams will be confiscated / detained by the customs authorities. Carrying any quantity of gold bars or bullion or bullion without declaration is absolutely illegal. Passengers carrying gold without declaration will be detained and arrested and a criminal case will be filed and handed over to the nearest police station.

Instructions on carrying cigarettes

A person can carry a maximum of 1 carton or 200 cigarettes for his personal needs. Any amount of cigarettes or any amount of Vape or Liquid Nicotine in excess of 1 carton/200 bags will be confiscated / detained by the customs authorities.

(Liquor) Instructions for carrying Liquor

No Bangladeshi passport holder can carry alcoholic beverages. All such imported alcoholic beverages will be confiscated / detained by the customs authorities. However, a passenger holding a foreign passport can bring up to one liter of liquor or alcoholic beverages (eg: spirits, beer etc.) duty free

What to do in case of carrying mobile set

A passenger can carry maximum 2 mobile sets tax free. However, 6 more mobile sets are exempt subject to payment of certain amount of duty (tax). BTRC requires No Objection Letter (NOC) for sale of more than 8 mobile sets. In case of failure to show NOC of BTRC, all mobile sets in addition to 8 sets will be confiscated / detained by customs.

Instructions in respect of excess goods carried with passenger

Goods carried are exempt from payment of duties / taxes unless considered commercial. However, any quantity of goods brought for commercial purposes will be seized /detained by the customs authorities.

Dos and Don'ts for Carrying Laptop / Computer

A passenger can bring an Old / New Laptop / Computer with him.

Instructions on Carrying Firearms

The carrying of all types of firearms by passengers is completely prohibited. However, subject to the approval of the Ministry of Commerce, a passenger can carry an Air Gun /Air rifle with a tax of Taka 5,000.

Instructions regarding import/export of foreign currency

Incoming passengers can bring any amount of foreign currency accompanied (Accompanied) from abroad. However, if more than USD 10,000 or equivalent amount of foreign currency is brought from abroad, FMJ form must be filled and declared at customs. In case of outbound passengers, foreign currency should be endorsed in the passport.

Sample Event- 01

Mr. 'X', a Bangladeshi passport holder, brought the following goods with him when he came to Bangladesh from Dubai:

- * Two Gold Bars Weighing 20 Tolas
- * Carton Cigarettes of 200 Shalaks Each
- * 1 Bottle of Wine
- * 3 Hammers, 5 Locks

In this case Mr. 'X'

You can take it without duty (tax):

1 Carton of Cigarettes, 3 Hammers, 5 Locks

You can take it with duty (tax):

By declaring at the customs hall, the two gold bars can be taken with a total of 40,000 (forty thousand) taka in the customs (tax) deposit in the bank subject to showing the receipt.

Cannot take:

Another 1 carton of cigarettes and 1 bottle of liquor will be seized by the customs authorities with a Detainment memo issued to the passenger.

Sample Event- 02

Mr. 'Y', a Bangladeshi passport holder, brought 5 gold bars with him when he came to Bangladesh from Saudi Arabia.

In this case, Mr. 'Y' declared 2 gold bars at the customs hall and paid the applicable duty (tax). But he kept the other 3 gold bars hidden. If 3 undeclared gold bars are found in his possession after scanning due to non-declaration, all his gold bars will be confiscated/detained by customs and Mr. 'Y' will be handed over to the nearest police station after filing a criminal case.

In addition to the suppression of smuggling in the customs declared areas, the prevention of customs evasion, the Drug Control Act, the Foreign Exchange Regulation Act, the Import-Export Control Act, the Import Policy Order and other auxiliary and conventional laws are implemented in The Customs Act. As per 1969, the customs officers perform duties.
