

Cathay Pacific Visa® Card Mileage Renewal Offer

Terms and conditions

1. The Cathay Pacific Visa Card Mileage Renewal Offer (the "**Offer**") provided by Asia Miles Limited is valid from 1 July 2022, 00:00 to 31 December 2022, 23:39, both dates inclusive (the "**Promotion Period**").
2. Members who have fulfilled the following requirements (the "**Eligible Members**") will be entitled to the Offer:
 - i. Members do not currently hold and have not cancelled any principal card of Cathay Pacific Visa Card or Cathay Pacific Visa Signature Card (each an "**Eligible Card**") issued by Synchrony Bank (the "**Bank**") in the past 6 months from the date of approval of their current application for a principal card of the Eligible Card; AND
 - ii. Members have successfully applied for and been issued with an Eligible Card during the Promotion Period.
3. Under the Offer, Eligible Members can enjoy a mileage renewal fee waiver on miles earned under the time-based system including:
 - i. the balance of miles earned before 1 January 2020; AND
 - ii. the balance of miles earned before 1 January 2020 but expired and were deducted from 1 July 2022 onwards
 - iii. those miles will be renewed and fall under the activity-based system afterwards; while balance of miles earned from 1 January 2020 shall remain unchanged. All miles shall stay active as long as the Eligible Members earn or redeem miles at least once every 18 months. [Expiry policy](#) applies.
4. Eligible Members acknowledge that the Offer is provided by Asia Miles Limited. By participating in this Offer, Eligible Members agree that upon approval of the Eligible Cards, the Bank will provide the relevant information of the Eligible Members, including family name, given name and Cathay membership number to Asia Miles Limited for fulfilment purpose for this Offer only. However, the Bank accepts no liability for failure or delay in the provision of the Offer to the Eligible Members for any reason beyond the Bank's control. The balance of miles earned before 1 January 2020 including those expired and were deducted from 1 July 2022 onwards, will be automatically renewed within 6 to 12 weeks upon receiving such information from the Bank.
5. The Offer cannot be converted into bonus miles, cash rebate or cash, and is non-transferable.

6. The Eligible Member's Cathay membership account and Eligible Card must remain valid when the Offer is granted, otherwise Asia Miles Limited and the Bank have the right to forfeit the Offer or charge an amount equivalent to the value of the Offer.
7. Eligible Members understand and accept that the Bank is not the supplier of the Offer. The Bank shall bear no liability relating to any aspect of the Offer, including without limitation, their quality, supply, descriptions of the Offer provided by the relevant suppliers, false trade description, misrepresentation, mis-statement, omission, unauthorised representation, unfair trade practices or conduct in connection with the Offer provided by the relevant suppliers, their respective employees, officers and/or agents. The use of the Cathay membership account and the Offer is subject to the terms and conditions as stipulated by Asia Miles Limited and the relevant suppliers.
8. Asia Miles Limited and the Bank reserve the right to vary, extend, terminate and/or cancel this Offer or amend these terms and conditions at any time without prior notice. Any benefit or promotional offer for Eligible Members is subject to availability and Asia Miles Limited and the Bank may change such offer at their sole discretion from time to time without notice to the Eligible Members. Cathay Pacific Visa® Card 延長里數有效期優惠

條款及細則

1. 由亞洲萬里通有限公司提供的 Cathay Pacific Visa Card 延長里數有效期優惠 (「優惠」) 的優惠期為 2022 年 7 月 1 日凌晨 00:00 至 2022 年 12 月 31 日晚上 23:59 (GMT+8) , 包括首尾兩天 (「優惠期」) 。
2. 符合以下要求的會員 (「合資格會員」) 將可獲享此優惠：
 - i. 會員現時並未持有及於現時所申請由 Synchrony Bank (「銀行」) 發行之 Cathay Pacific Visa Card 或 Cathay Pacific Visa Signature Card (「合資格信用卡」) 主卡批核日期起計之過去 6 個月內沒有取消任何合資格信用卡主卡；及
 - ii. 會員於優惠期內成功申請並獲發出合資格信用卡。
3. 在此優惠下，合資格會員可獲延長在時間為本系統下所賺取的里數有效期，無須繳付服務費，包括：
 - i. 在 2020 年 1 月 1 日前所賺取的里數結餘；及
